Nanny Placements

*FEES:

Live-in	\$1800	
Come and Go Nanny	\$1500	(4 -5 days)
Part time Nanny	\$1250	(3 days or less)
Summer Girl	\$500	
Vacation Sitters	\$25	(per 24 hour period)

Fee payable upon hiring of referred applicant.

*GUARANTEE:

If for any reason the Live-in, Come and Go, or Part-time Nanny should be terminated or resigns for any reason within thirty (30) days of the employment start date, NN will refund the fee paid, less twenty-five percent (25%) of the total gross wages paid. If the Live-in, Come and Go, or Part-time Nanny is terminated by us for just cause (as reasonably determined) after thirty-one (31) days but before ninety (90) days of the employment start date, NN will make reasonable efforts to provide a replacement nanny. In such event, no refund of the fee will be made, and no fee will be due for the replacement nanny. The foregoing shall apply on a one-time basis only. Any subsequent nannies will, if requested by us, will incur an additional fee in the amount the amount set forth above.

HOURLY SITS

*All REQUESTS MUST BE SCHEDULED THROUGH NORTHFIELD NANNIES.

Please do not ask your Sitter for her telephone number or schedule with the Sitter additional sits, as it is against agency policy. Dates made directly with the Sitter will not be honored by this office.

*FOUR HOUR MINIMUM REQUIREMENT FOR EACH SIT.

*FEES

1-3 children	\$10.00-\$12.00 per hour to sitter
Additional children	\$.50 per child per hour
Hotel Sits	\$15.00 per hour to sitter
Northfield Nannies fee is \$15 per sit. The family is required to pay via credit card.	
Holiday sits are \$25. Additional, sitters make twice the above posted rates.	

*CANCELLATION FEE

If the client cancels with less than 24 hours notice, the cancellation fee constitutes four (4) hours times the hourly rate plus the \$15 agency fee. This amount should be forwarded to Northfield Nannies who will in return forward the Sitter's portion to her.

If the client cancels any time after the sitter confirms with the client on time and directions, the cancellation fee is a \$15 agency fee.

SHORT TERM LIVE-IN (VACATION OR TEMPORARY SIT)

*TWO WEEKS LEAD TIME IS ESSENTIAL. FOUR TO SIX WEEKS LEAD TIME IS PREFERABLE.

*SUGGESTED FEES FOR SITTERS

1 or 2 children	\$125 per day
Additional children	\$10 per day
Agency scheduling fee	\$25 per 24 hour period
